Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies. • Secure Mortgage Company does not share with nonaffiliates so they can market to you.			
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. • Secure Mortgage Company doesn't jointly market.
